



REGISTRATION INFORMATION

2008 Annual Convention & Exposition

Registration Deadline: April 10, 2008

No Registrations accepted after April 10, 2008; will be treated as walk-ins onsite.

Who Can Attend?

Attendance is limited to **Association-affiliated credit unions**. Association membership fee must be paid prior to registration. Each credit union is entitled to one delegate and one alternate.

How Much Does It Cost?

The **Conferee Fee** includes admission to all non-ticketed events at the Annual Convention & Exposition:

Early-Bird Registration

(Payment Received by March 6, 2008):

- ▶ **Credit unions under \$20 million** — Registration is \$125 per person.
- ▶ **Credit unions over \$20 million** — Registration is \$250 per person.
- ▶ **Discount for 5 or more registrants** — \$25 per conferee (*applies to credit unions over \$20 million only*).

Payment Received after March 6, 2008:

- ▶ **Credit unions under \$20 million** — Registration is \$175 per person.
- ▶ **Credit unions over \$20 million** — Registration is \$300 per person.
- ▶ **Discount for 5 or more registrants** — \$25 per conferee (*applies to credit unions over \$20 million only*).

The **Spouse/Guest Registration Fee** of \$75 per person includes admission to the Exposition, Continental Breakfast, and Youth Ambassador Contest.

All convention attendees must be registered.

The Saturday morning Business Session is open to all Association-affiliated credit unions.

Special Ticket Events

Tickets are required for the CEO Exposition Reception, the Pennsylvania Credit Union Foundation (PACUF) Breakfast, and the Spouse/Guest Special Event. Your seating assignment card is required for the Banquet and Entertainment. Seating for the banquet is reserved on a first-come, first-served basis.

Special Offer – CU Young Professionals

With each two (2) paid conferee registrations, your credit union receives one (1) free registration for a credit union young professional under age 35. There is a fee for the PACUF Breakfast and for the Banquet & Entertainment if the registrants choose to attend these events.

When Do We Get Our Tickets?

Tickets will be distributed at the Association Convention Registration Desk along with your other materials.

Badges Must Be Worn At All Times

The color of your badge determines your admission to Convention activities:

- ▶ **Yellow Conferee Badge** includes admission to all activities except where a ticket is required.
- ▶ **Green Spouse/Guest Badge** admits you to the Expo, Continental Breakfast, and Youth Ambassador Contest.

Cancellation Policy

- ▶ Cancellation of convention registration and ticketed events **MUST** be made in writing **by April 10, 2008**.
- ▶ A refund, less a \$50 processing fee per registrant, will be granted for requests received by April 10.
- ▶ No refunds are granted after April 10.
- ▶ Substitutions are welcomed and preferred.
